## Resolution before the July gathering of General Synod of the Anglican Church of Canada on the Marriage of Same Sex Couples

A resolution will be brought for discussion and decision to the General Synod in July which asks General Synod to allow the marriage of same sex couples in church. This has been a matter which has been before Canadians and Anglicans for several years.

On July 20, 2005, Canada became the fourth country in the world, and the first country outside Europe, to legalize same-sex marriage nationwide with the enactment of the Civil Marriage Act which provided a gender-neutral marriage definition. Court decisions, starting in 2003, had already legalized same-sex marriage in eight out of ten provinces and one of three territories, whose residents comprised about 90% of Canada's population. Before passage of the Act, more than 3,000 same-sex couples had already married in those areas. Most legal benefits commonly associated with marriage had been extended to cohabiting same-sex couples since 1999 (From Wikipedia, the free encyclopedia).

In 2013 the General Synod passed a resolution directing the drafting of a motion “to change Canon XXI on marriage to allow the marriage of same-sex couples in the same way as opposite-sex couples, and that this motion should include a conscience clause so that no member of the clergy, bishop, congregation or diocese should be constrained to participate in or authorize such marriages against the dictates of their conscience.” Such a motion will be considered by the 2016 General Synod (Anglican Journal).

Following the 2013 General Synod, the Primate put in place a Commission on the Marriage Canon. This group invited submissions from members of the Anglican Church of Canada between April 28 and September 30, 2014. Around the same time, our parish of St. John's had carried out a broad consultation before presenting Rev. Louis Quennelle to our Bishops, to be received as a priest in the Anglican Church of Canada. Louis and his spouse, Robert MacMillan are active parishioners and were married in the United Church. The consultation allowed for gatherings of large groups, smaller gatherings as well opportunities for individuals to speak privately with the Rector and to write their concerns or support in writing. This was a very valuable experience for us all allowing anyone who wished to have their opinion listened to with respect and care. After more than a year of consultation, the Parish Council voted unanimously to present Louis for reception as a priest in our parish and diocese.

Parish Council has taken up this matter and has committed to a period of study and consultation following the July meeting of General Synod. The following two motions were approved by Parish Council at their May 26<sup>th</sup> meeting. Letters were sent to Archbishop Fred Hiltz, Primate of Canada and Chair of the House of Bishops and to Bishop Ron Cutler, our Diocesan Bishop.

### **Motion 1**

The members in attendance of the Parish Council of St. John's, Lunenburg, Nova Scotia to write a letter to both Bishop Ron Cutler and The House of Bishops, confirming that the members of this Parish Council believes that all love is consecrated by God and that a covenant relationship between any two people in mutual love is a sacramental reflection of a relationship between God and the Church. As we hold this to be true, we urge Bishop Ron Cutler and the House of Bishops to support a resolution that will be before the General Synod this summer to change the Anglican Church of Canada's marriage canon to allow same sex marriage.

## Resolution before the July gathering of General Synod of the Anglican Church of Canada on the Marriage of Same Sex Couples - Continued

### Motion 2

The subject of same-sex marriage is a contemporary and very personal issue. As such, the Parish of St. John's Lunenburg commits, over the course of the next 12 months (through June 2017), to conduct a process of broad consultation with parishioners that will combine an educational component on the process to change current Anglican Church doctrine while gaining a stronger understanding of our parishioners views on the direction the church should be taking. In addition, we will request that the Diocese encourage other Parishes to take a similar approach to provide the Diocese and the General Synod broader ground roots input and guidance to develop an appropriate plan of action.

You are encouraged to write both Archbishop Fred and Bishop Ron about this, freely expressing your views. Contact information is found at the end of this article.

It is important to remember the process of a change in a matter of doctrine. The resolution must pass with a 2/3 majority in the three 'houses' of General Synod, the laity, the clergy and the bishops. If it passes, before any change is made, it will be sent to the wider church for further study and then brought forward at the next General Synod meeting in 2019, where once again it must have a 2/3 majority in the three houses.

Let us commit ourselves to prayer for Archbishop Fred and all the members of General Synod, especially those from our Diocese of NS & PEI.

## Physician Assisted Death in Canada

Canadians and Anglicans across the country are coming to terms with a decision by the Supreme Court of Canada in February of 2015 which ruled that adults with grievous and irremediable medical conditions are entitled to physician assisted suicide. The House of Commons has passed Legislation to govern and regulate this matter which is currently before the Senate of Canada.

Legislation on euthanasia in Canada distinguishes between passive euthanasia (withholding or withdrawing of life-preserving procedures including water and food) and active euthanasia (intentionally killing a person to relieve pain). Whereas passive euthanasia is legal in Canada, active euthanasia was previously prohibited under the criminal code as a form of culpable homicide. The prohibition on voluntary euthanasia was overturned in a February 2015 decision by the Supreme Court (*Carter v Canada (AG)*), which ruled that adults with grievous and irremediable medical conditions are entitled to physician assisted suicide. The ruling was stayed by the court, and will not take effect until June 6th, 2016 so as to allow time for the government to amend the criminal code. The Anglican Church has been talking about this since about 1975. The first report that came out [was] on “[Considerations Concerning] the Passage from Life to Death,” and so the conversation has been going round as various challenges to the law have come up. One of the key things in our conversations is how do we look at the special risks for people in society...who are already vulnerable by the nature of their illness? - Bishop Jane Alexander, Diocese of Edmonton

Bishop Stephen Andrews of the Diocese of Algoma has written the following letter which is a good introduction to this subject.

“There’s a concern that there might be social or family coercion or dealing with people who have got undiagnosed depression and the pressures of all of those kinds of things for very vulnerable people... We don’t quite know how this picture is going to unfold.

“In the church we spend a lot of time with people who are really suffering and facing all kinds of end-of-life decisions... We want to protect... human dignity all the way through and working out how people confront death because we don’t live in a society that has totally always embraced... that sooner or later it happens. And [the question is] how can we support people at those times of their lives when they are in the most difficult situations of trying to make decisions?

“I suspect that one of the questions that families might have for chaplains and clergy is, 'Do you think I am doing the right thing?' Those kinds of conversations are going to be very difficult to walk alongside because it is for people to make those decisions for themselves. Our job is to be there and provide prayerful and loving support and to proclaim hope even in these darkest of times.

“There are Christians who will be on both sides of the discussion that's going to happen and they'll begin from the same starting place... from the sovereignty of God. Both groups will want to protect human dignity, preserve the freedom of individual peoples, choose how to confront our frailty, and in the face of death, they'll all view life as a gift that has been given to us... We do understand that we are called to have hope in suffering and in suffering we find God, but that doesn't imply that we think people should be having painful deaths, which is why I think, for us, there's been a real push in terms of palliative care and hospice care.”

One of the primary concerns is current levels of palliative care and hospice care in Nova Scotia and in particular, on the South Shore. The need is very great and is increasing and current resources are woefully insufficient. You are encouraged to make your views known to Premier Stephen McNeil as well as to the Minister of Health, the Honourable Leo Glavine.

Let us hold fellow Canadians in prayer, especially those who are in any form of suffering.
